Information & Guidelines

Parents and Students: Read Carefully and Keep for Future Reference

P3 General Information:

- P3 will be held at River Hill High School, 12101 Clarksville Pike, Clarksville MD 21029.
- This event is an alcohol-free/tobacco-free/drug-free celebration full of fun activities in a safe and supervised environment following the RHHS Prom.
- P3 is a PTSA sponsored event, not school sponsored.
- A free t-shirt, food, beverages, a movie, fun games, DJ, mock casino, other activities, and the chance to win raffle prizes are included in the ticket price.

P3 Ticket Sales Information:

- Tickets must be purchased in advance – they will NOT be sold at the door.
- P3 tickets are \$12 per person and will be on sale from April 19-27 during all lunch shifts.
- Payment can be made by cash or check (payable to RHHS PTSA).
- P3 payment via check **cannot be combined with Prom payment.**
- Tickets are non-refundable and non-transferable.
- You do not have to attend the Prom to participate in the Post Prom Party.
- Every RHHS junior and senior may buy one ticket for themselves and one for a guest.
- A guest can be a RHHS freshman or sophomore, a student from another high school, or any young adult between the ages of 18 and 21.
- A **permission form signed by a parent/guardian** is required for EACH ticket purchase.

P3 Rules & Guidelines:

- NO ALCOHOL, NO DRUGS AND NO SMOKING ARE ALLOWED. If a student or guest exhibits any signs of usage of said items, the parent/guardian will be called to pick up the student or guest.
- Appropriate behavior is expected at all times.
- Check-in begins at 11pm and ends at 12am. NO student will be admitted after **12am.**
- **Picture ID** (school ID or driver's license) and your ticket is required for entry to P3. Wristbands must be worn at all times during the party.
- Guests must arrive to P3 with their River Hill HS student host/date.
- You are encouraged to come directly from Prom to P3. Changing areas will be available as well as a secured Clothing/Bag Check area.
- All bags will be inspected prior to entry and must be stored in Clothing/Bag check during the event. No liquids of any kind may be brought in (i.e. perfume, beverages, etc.).
- P3 is not a lock-in. A student may choose to leave any time after 1am, but cannot re-enter.
- Raffle prizes will be drawn from 12:15am -3am. **YOU MUST BE PRESENT TO WIN!**
